Dear Member

I am writing to all members summarizing the Club's performance over the last 12 months, together with an update as to the Club's plans for the forthcoming year, 2024/25.

A. THE YEAR TO DATE.

Last year was a full year of operations with a continued increase in our membership following the disruptions caused by the pandemic in previous years. We have welcomed over 50 new members over the last 12 months.

All the Indoor League Fixtures and Club Competitions for 2023/24 commenced in October 2023 and were duly completed on schedule in April 2024.

The 2024 Outdoor Season is nearing completion and, whilst support for the friendly match program has been difficult at times, we have completed most of the matches programmed – a big thank you to our club captains, Steve and Angie Isaac for the immense effort they have made over the year in arranging teams for all the fixtures.

CONGRATULATIONS TO: -

All our KLV and KL teams and the KL "A" squad on winning the KENNET LEAGUE, the first time in many years!

Our Ladies who have had a fantastic season, winning both the THAMES VALLEY LEAGUE and the COUNTY TOP CLUB, a trophy Desborough has never won before.

Our members who qualified to play in the National Finals at Leamington Spa – 10 members, 6 men and 4 Ladies in different playing formats. This number of members playing in the National Finals is the best achievement in over 10 years – well done to all!

We are hoping to retain our excellent relationships with both Bowls England and EIBA, and hopefully help us to attract more of the major National and International Bowls events in the future.

During the year we have been raising money for the Thames Hospice. Once again, many thanks to our members and sponsors for their generosity.

Anna's Catering was appointed as Club caterers, as from the 1^{st of} June 2023 and we are continuing to ensure improvements are being made going forward with the quality of service, availability, and the choice of menus.

Ellora Ltd continue as our bookkeepers and accountants with Jasbir Notay as the Club Treasurer. Many thanks to Jasbir and her team for their continued support.

These last 12 months have been a very busy time with everyone working tirelessly to provide, not only excellent facilities for our members bowling activities, but also to encourage both new and our existing business and charitable organizations to use our facilities. The commercial income derived from these commercial lettings is an essential part of the Club's overall finances.

B. THE FUTURE

1) GENERALLY

With the increases in our bowling and commercial activities over the last 12 months, we have now had to recruit several new management and staff members to ensure, we can, not only provide an excellent service to our existing membership and commercial clients, but also market the Club facilities to attract new members/clients.

Club Bowls Operations Manager- With our current Club Manager, Mark Peachey, due to relinquish his post later this year, we are now currently seeking to recruit a new part time role to take over from Mark with the planning and ongoing management of all the Club's bowling activities.

A new 5 - year Business Plan with financial projections has been approved and thanks to our management team and the support of our Finance and Management Committees we have now agreed a new budget going forward, which we believe is achievable and will allow us to reach a break-even point (cash) in 2025/26.

2) MEMBERSHIP

With the after-effects of the Pandemic, we saw an initial reduction in our membership, however over the last months we have managed to attract new members from the surrounding areas and would now summarize our current position as: -

3) SUBSCRIPTIONS AND GREEN FEES 2024/2025:

We are still being affected by the market economy, with many basic costs continuing to rise. Due to these increased costs, it is essential that we continue to budget accordingly to minimize any potential losses and ensure that we break even, in cash terms by the year 2025/26.

To help address the future financial challenges, our Treasurer, Jabir Notay, has prepared various financial scenarios, within a 5-year budget framework, considering the current and potential future increases in operational costs. Various options were then presented to both the Finance and the Management Committees for discussion and final approval.

The Committees concluded that we had no alternative but to effect price increases overall to ensure our financial position remains stable over the next 5 years, with sufficient cash reserves maintained for future essential expenditure. It was therefore agreed that the increase in costs overall should be met primarily by increases in annual subscriptions and green fees, the latter having remained unchanged over the last 2 years. (the green fee changes also include a wider availability of rinks for 1-hour sessions at a lower rate). The fees payable for the year 2024/25 are outlined below: -
